

## **Del Monte Foods Company Guidelines For Linking To The Del Monte Foods Web Site**

Del Monte Foods Company ("**Del Monte**"), a Delaware corporation with its headquarters at One Market, San Francisco, CA 94105, appreciates your interest in linking your web site, located at the URL set out below (the "**Linking Site**"), to Del Monte's Web Site, located at [www.Delmonte.com](http://www.Delmonte.com) (the "**Del Monte Site**"). In order to understand your rights and responsibilities as a user of Del Monte's trademarks, trade names and other proprietary information, Del Monte asks that you review and agree to the following guidelines (the "**Linking Guidelines**"):

1. Use of Del Monte Trademarks. Subject to the restrictions in these Guidelines, Del Monte grants you a nonexclusive, limited license to use the *Del Monte* shield and/or trade name for the sole purpose of identifying your link to the Del Monte Site. The *Del Monte* shield and trade name may be displayed only in the form set out in the Del Monte Site. This limited license is solely for use in identifying the link and may not be used for commercial purposes. You may not link to the Del Monte Site in such a way that would indicate or suggest Del Monte sponsorship, affiliation or endorsement of the Linking Site, company, products or services.
2. Framing. You may not (a) "frame" or otherwise impose editorial comment, commercial material or any type of identification on (or in proximity to) content displayed on the Del Monte Site ("**Del Monte Content**"), (b) alter or modify Del Monte Content, or (c) "cut and paste" or otherwise reproduce Del Monte Content on the Linking Site.
3. No Archiving. Your link must be to the current Del Monte Site only. In permitting linking, Del Monte does not grant you the right to reproduce, modify, cache or archive the Del Monte Content for any purpose.
4. No Disparagement, Etc. The Del Monte shield and/or trade name may not be used in a derogatory, offensive or tortious manner. The Linking Site may not contain content that could be construed as distasteful, offensive or controversial, and should contain content that is appropriate for all age groups.
5. Link At Your Own Risk. Del Monte makes no representations or warranties regarding the Del Monte Site and the Del Monte Content, which is provided "as is."
